4. First aid measures

General information

Move victim out of danger zone and lay down.

5. Fire-fighting measures

Suitable extinguishing media

Extinguishing powder. Carbon dioxide (CO2). Water fog. alcohol resistant foam.

Extinguishing media which must not be used for safety reasons

High power water jet.

Special exposure hazards arriving from substance or preparation itself, combustion products, resulting gases

Swims on the water. Vapours are heavier than air and will spread at floor level.

Special protective equipment for fire-fighters

In case of fire: Wear self-contained breathing apparatus.

Additional information

Cool endangered container in case of fire.

6. Accidental release measures

Personal precautions

Provide adequate ventilation. Wear suitable solvent-proof protective clothing according to EN 465.

Keep away from sources of ignition. No smoking. Avoid contact with skin and eyes.

Do not breathe gas/fumes/vapour/spray.

Environmental precautions

Do not empty into drains or the aquatic environment. In case of gas being released or leakage into waters, ground or the drainage system, the appropriate authorities must be informed.
