After contact with skin

Take off immediately all contaminated clothing, including underwear and shoes . Subsequently wash again with: Water and soap.

Immediately flush eyes with plenty of flowing water for 10 to 15 minutes holding eyelids apart. Consult physician.

After ingestion

Let water be swallowed in little sips (dilution effect). Consult physician.

Advice to doctor

Warning about danger of aspiration.

5. Fire-fighting measures

Suitable extinguishing media

Extinguishing powder. Sand. Carbon dioxide (CO2). alcohol resistant foam.

Extinguishing media which must not be used for safety reasons

High power water jet.

Special exposure hazards arising from substance or preparation itself, combustion products, resulting gases

Formation of decomposition products possible. In case of fire and/or explosion do not breathe fumes.

Special protective equipment for fire-fighters

In case of fire: Wear self-contained breathing apparatus.

Additional information

Cool endangered container in case of fire. Beat down gas/vapours/mist with water spray. Contaminated fire-fighting water must be collected separately.

6. Accidental release measures

Personal precautions

Wear a self-contained breathing apparatus and chemical resistant suit. Keep away from sources of ignition. No smoking.

Environmental precautions

Beat down gas/vapours/mist with water spray.

Do not empty into drains or the aquatic environment.

In case of gas being released or leakage into waters, ground or the drainage system, the appropriate authorities must be informed.

Methods for cleaning up/taking up

Absorb with liquid-binding material (e.g. sand, diatomaceous earth, acid- or universal binding agents). Prevent spreading over great surfaces (e.g. by damming or installing oil booms).
